WHEREAS, the Village of Loomis, Nebraska, is desirous to enter into an agreement for the purchase of certain real estate from Ryan and Stephanie Rodenbaugh; and WHEREAS, Ryan and Stephanie Rodenbaugh are agreeable to entering into a purchase agreement to sell certain real estate to the Village of Loomis as provided therein. WHEREAS, the Board of Trustees of the Village of Loomis provided proper notice of and held a public hearing concerning said purchase of real estate.
